Theological thinking connects faith and life.

It is thinking about God (theos) and how He acts and has revealed Himself in Jesus and His Spirit—and what our faith in Him means to every aspect of life: our relationships, family, parenting, ethics, social media, education, work, entertainment,

viewing, reading, values, attitudes, health, politics, history, etc.

Before meeting Jesus, the apostles' thinking was shaped by Judaism and their cultures. But once they met him and realized Who He was, **Jesus became their rule of faith and practice.**



## Paul's district work

We will first consider: (1) the main methods or approaches used by the apostles on Paul's three major missionary journeys—and, also his work from Rome, (2) how teams were formed, and, (3) the relationship between headquarters, mission hubs, teams and local churches planted.





Oikos mapping —is a practical and strategic place for all to start.



Imagine Jesus' oikos map when He called His first disciples at the Jordan (John 1:35-51), or that forming in Peter's mind as he left Joppa for Caesarea (Acts 10:1-48). Imagine Paul's after a few of days in Philippi (Acts 16:11-40), and the complexity of his map from His mission hub in Ephesus (Acts 19:1-10). And, what kind of map was forming as he wrote his letter to the Romans—listing name after name of believers in Rome, and imagining their connections with people far from God (Romans 16:3-16)?

This is where movements start.

#### Engaging people of peace.

When equipping the 72 extra disciples in movement leadership—as with the apostles and the women who travelled with Him—Jesus pinpointed the key qualities of *people of peace* (Luke 10:1-9). They are found in every *relational* stream, and in observing Jesus' disciple-making and movement-building we note:

Four characteristics of people of peace

- 1. Welcoming—often demonstrated in hospitality.
- 2. Receptive—to you and the Spirit in you.
- 3. Reputation—which may be good or bad.
- 4. Influential—when they follow Jesus others notice and follow.

These people are *centres of influence*—not buildings or programs, but the key people within an *oikos* or *ethnē* who can bring many to Christ. Jesus found the Samaritan woman at the well and the demoniac on *the other side*. Neither were the leaders of their communities, but when they followed Jesus they had great influence among the people of their towns and regions. Paul found Sergius Paulus at

Paphos, and Lydia and the jailer at Philippi, each influencing their *oikos* to follow Jesus.

Lead each *person of peace* to Jesus, help them draw their own *oikos map*, teach them the simple *Discovery Bible Reading* process, and mentor them in multiplying.

#### Ethnē mapping—for movement leaders

What preparation is being made to reach new districts today—people groups, towns, cities and suburbs with the gospel? A common feature in the board rooms of denominational offices is a map identifying where churches, schools and clinics are located. This defines the organization by its buildings and institutions, but movements are defined by the vision of no-place-left.

Ethnē mapping provides this bigger picture, for it identifies all un-entered relational streams. It is important to hear stories of service and faithsharing next door, for this is where disciple-making happens and movements are founded. However, movement leaders cast the glocal vision—local, regional and global.

Jesus commissioned His followers to make disciples in all *ethnē* (Matthew 28:18-20), and Paul cast the vision for the western regions of the Roman empire. Those who are *church multipliers* and *movement catalysts* will have their *ethnē map*.

- 1. Identify the *ethnē*. What people groups have not been reached? What towns, cities, suburbs, growth corridors, migrant populations, districts or states are unreached?
- 2. Plans to enter. Who will enter this people group? Who are the *seed-sowers?* What specific plan will be followed, and when will the team enter the un-entered district?



Strategic questions that grow from *ethnē mapping* are:

•	disinherited—for they will be key to the next generation of disciplemaking?
•	Who are <i>people of peace</i> —for they will reach their relational streams?
	Will reach their relational streams?
•	Who are the <i>church planters, church multipliers</i> and <i>movement catalysts</i> focused on these un-entered people groups and districts?

#### 5. CHURCH PLANTS: all New Testament churches were:

- Home based. Of course, the issue is not the place, but that these were local, relational communities of people walking together on the paths of life.
- Small and relational—often no more than 20 to 25
  people, after which they had to split up because they
  could no longer fit in the room. This kept all involved.
- Inclusive and participatory. The gospel eradicated discrimination on the basis of nationalism, gender or social status, and there were no spectators.
- Affirming. The participation of women was natural.
   They were gifted and involved in all aspects of church life. Their leadership reflected the dignity Jesus gave them.
- Sustainable. No money was contributed to "start the work" in a city, nor sent to sustain an institutional system. As one body, they gave to help the poor.
- Zero dollar. They did not spend money on facilities, parking lots, or promotion, nor were they dependent upon allocations from a conference office.
- One body. There was not a gentile church and a Jewish church. All groups were, together, the body of Christ.
- Connected. Through elders or overseers in each city, all fellowships were connected—but not institutionally as we are today. It was the gospel and Spirit that bound them.
- On the paths of life. Church was where families and neighbours lived, where their meals, families and lives were shared. They didn't drive away to attend church.
- Mission hubs. Church events weren't planned by the leaders in Jerusalem. Each church took responsibility to share the gospel in their town, city, region or province.
- Reproducible. There were multiple faith communities or churches in each town, built on expanding relationships. This simple type of church is easily reproducible.
- In conversation: They shaped their communities, but were also shaped by the experiences, hurts and joys of their communities.
- Cruciform. They modelled their fellowship on the idea that others are of greater value than themselves, and they would go to the cross for them.

In that movements depend upon *planting teams* and *multiplying local churches* our Movement Multiplication Plan is developed around (1) movement leadership, and (2) mission hubs.

#### 1. Movement Leadership

There are five levels of leadership in movements—all are disciple-makers and church-planters:

- 1. Seed-sowers and disciple-makers. (Don't count members, count disciple-makers)
- 2. Church planters.
- 3. Church planting multipliers.
- 4. Equippers of multipliers.
- 5. Catalysts for movements—who strategically plan to enter new areas and multiply.

These are not positional, as in institutionalized churches—but rather, they make things happen.



- 1. Each leader's personal plans for seed-sowing, disciple-making and church-planting:
- Develop an ethnē and oikos map—and start praying and connecting:





